## **Editorial Policy**

Australia and New Zealand Journal of Social Business, Environment and Sustainability (ANJSBES) publishes original, rigorous, well-done empirical research (both quantitative and non-quantitative) as well as theoretical/conceptual research papers having potential for field applications and in-depth literature reviews. Articles focusing on theory building or testing based on empirical research with strong managerial focus are especially encouraged. The papers submitted to this journal should have significant implications for academics and practitioners in real world situations. The editorial policy of this journal is outlined below:

1. All manuscripts submitted to this journal are subject to blind peer review to at least two subject matter experts. At least one reviewer will be an expert in the relevant area. Upon the reviewers' recommendations in favour of the acceptance or rejection of a manuscript, the Editor makes the final decision to consider the publication in its present form, or to ask its author for resubmission, or rejection if otherwise.
2. The decision on the acceptance/rejection of a manuscript is based on the average score given by the reviewers. The reviewers grade a submitted manuscript on a scale of 1 to 5 given the overall merit of each manuscript. To be accepted for publication, the manuscript must obtain an average score of not less than 2.5. It is the final decision of the Editor whether an article will be finally accepted or rejected.
3. The Editorial Board ensures that only previously UNPUBLISHED original research work shall appear in ANJSBES. Submission of an article to this journal implies that the work performed by the author is original and has not been published previously (except in the form of an abstract or as part of a published lecture or academic thesis), that it is not submitted elsewhere or under consideration for publication elsewhere, that its publication is approved by all authors and implicitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, will not be published elsewhere in the same form, in English or in any other languages, without the written consent of ANJSBES.

4. The ANJSBES Editorial Office reserves the right to adjust the contents (by editing or otherwise altering all contributions) of a manuscript to follow the uniformity of its publications. Author(s) will receive proofs for approval before publication.
5. There are concerns in academia about plagiarism, including self plagiarism and duplication of publication(s). All submissions will be checked for potential plagiarism. We may use relevant software (for example CrossCheck powered by iThenticate or Turnitin) to detect plagiarism. Articles published fully or partly in other publication outlets in similar or significant different format will not be reviewed. All manuscripts containing plagiarism (including self-plagiarism, duplication of publication and dishonesty) will be immediately rejected.
6. The corresponding author must comply with the submission checklist by ticking in the relevant boxes.
7. There is no submission fee to this journal. However, there is a minimum acceptance fee of US\$300 for all manuscripts accepted to this journal. This fee will cover managing the submission of your paper, setup costs, other "first-copy" costs of your paper; the cost of archiving your paper in the issue of the journal at the journal web-site; language editing and journal specific formatting of your paper. This fee will be waived only for solicited manuscripts.
8. The review time, length and publication may vary subject to the availability of subject matter experts to review the manuscripts. We anticipate that the initial review will be completed within six weeks. All accepted papers should be published in the following issue, unless advised otherwise.
9. Copyrights for articles published in ANJSBES will be retained by the authors, with first publication rights granted to ANJSBES. The journal/publisher is not responsible for subsequent uses of the work. ANJSBES will not be liable to take an action for possible infringement of authors' published work in ANJSBES.
10. For privacy reasons unless otherwise advised by the authors(s), the journal will not publish author(s)' email addresses anywhere in the journal and this will not be made available to any other party. The journal, however, will publish the authors' full institutional affiliations.
11. ANJSBES will acknowledge the receipt of each submission and after performing a review, only the review report will be sent to the corresponding author. Authors are advised to safely keep a copy of their work as ANJSBES will not return a copy of the submitted manuscript.
